# The Royal Hogs Calling Contest – Official Guidelines and Rules

Clash Royale's The Royal Hogs Calling Contest (the "Contest") is subject to these Official Guidelines and Rules ("Guidelines and Rules"), which are binding on matters relating to the Contest. Entering the Contest is free, and no purchases are necessary to enter or to win. The Contest is organized by Supercell Oy ("Supercell").

BY ENTERING A SUBMISSION OR OTHERWISE PARTICIPATING IN THE CONTEST, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT. READ THEM CAREFULLY BEFORE ENTERING.

## Who can enter?

Except as otherwise specified in this section, the Contest is open worldwide to anyone aged 13 years or older residing in a country where Clash Royale is available for download and play through Supercell's official channels.

If you would like to participate in the Contest, but are under 18 years of age or the age of majority as defined in your country of residence, you must have permission from a parent or legal guardian to enter.

In order to enter, you also need a valid Supercell ID account.

#### How to Enter?

You can enter by recording and submitting a hog call on the contest website ("Submission") using the hog recorder. Supercell only accepts submissions posted directly on the website.

The Submission needs to be recorded in English, and must be kept to under 15 seconds.

# When is the Contest?

The Contest period begins on November 5th, 2025 at 00:00 AM Eastern European Summer Time ("EEST") and ends on November 15th, 2023 at 11:59 PM EEST (the "Contest Period"). Submissions must be received during the Contest Period to be eligible to win.

The winner will be announced on November 22nd, 2025.

Supercell reserves the right to modify, suspend, or cancel the Contest if necessary for legal or technical reasons.

## How Are the Winners Chosen and What Are the Prizes?

After submitting your entry, it will be sent to be reviewed by Supercell's moderation team. Once the review has been completed, it will appear on the contest website for community voting. Participants and visitors can listen to and "like" their favorite hog calls directly on the website.

Each person may vote for multiple entries but cannot vote for the same entry more than once. At the end of the Contest Period, the twenty (20) entries with the highest number of votes will move on to the final round. In this round, Supercell's internal team will review the top entries and select one (1) winner. The winning hog call will be featured in-game as the official sound of the Royal Hogs Evolution ("Prize").

The potential winner will be contacted by Supercell's team in-game on November 22nd, 2025.

Upon notification from Supercell, the winner shall have seventy-two (72) hours from the date such notice was sent to respond and provide any information or materials requested by Supercell. For the avoidance of doubt, the Prize cannot be exchanged for substitute prizes or cash. In the event a winner cannot be reached or cannot or will not accept or receive the Prize for any reason, Supercell reserves the right, at its sole discretion, to select an alternate winner from the remaining Submissions.

#### What Can and Cannot Be In the Submissions?

- Your Submission must be entirely original and created by you.
- You may not copy or use any material from other sources, and your Submission cannot include third-party content (like music) unless you have permission from the copyright holder. By entering, you (or your parent or legal guardian) confirm that your submission doesn't infringe on anyone else's rights and that you've secured any permissions needed. Supercell shall have the authority to disqualify a Submission if they believe, at its sole discretion, that it potentially infringes on copyright or might do so in the future.
- Your Submission must not contain any personally identifiable information, such as names, phone numbers or addresses.
- Your Submission must be respectful and suitable for all audiences. This means the Submission must not contain personal attacks directed at anyone, content promoting racism, bigotry, hatred or harm against any group or individual and promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age, or references to nudity, animal cruelty, alcohol, tobacco, drugs, pornography, weapons, betting or gambling, or any companies, products, or services related to the above, or any other offensive or obscene subject matter as determined in Supercell's sole discretion.
- Your Submission must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the entry was created.
- Your Submission must adhere to Supercell's Terms of Service (<a href="https://supercell.com/en/terms-of-service/">https://supercell.com/en/terms-of-service/</a>) and Fan Content Policy (<a href="https://supercell.com/en/fan-content-policy/">https://supercell.com/en/fan-content-policy/</a>).

Supercell may, in its sole discretion, remove or disqualify any Submission that doesn't follow these Guidelines and Rules, and delete or otherwise remove any such Submission from any of its channels.

## How Will the Submissions be Shared and Used?

The information you provide will be used only in accordance with all applicable data protection laws and Supercell's privacy policy, which can be found at <a href="https://supercell.com/en/privacy-policy/">https://supercell.com/en/privacy-policy/</a>.

As a condition of entry, you hereby grants to Supercell a non-exclusive, perpetual, irrevocable, worldwide, transferable, sublicensable, and royalty free license to use, modify, reproduce, prepare derivative works of, distribute, perform, and display the Submission in any and all media throughout the world and for whatever purpose Supercell deems. You shall not be specifically compensated for their Submissions or for granting Supercell any of these rights.

While Supercell will seek to post the Submission in the form as provided at the time of entry, you understand that Submissions may be altered from their original forms and that Supercell reserves the right to modify the Submissions in its sole discretion.

For marketing purposes, Supercell has the right to use your account ID prior to, during, or after the Contest in any media without compensation or prior review. At any time before, during or after the Contest Period, Supercell may choose to post or distribute your Submission, your account ID, and profile information online for promotional and entertainment purposes.

Sharing these Submissions on the website does not imply that these Submissions is a winning Submission. Should you be unhappy with your submission, Supercell will make best efforts to fulfill requests to remove a Submission from the website.

## What Are Some Other Conditions for Entering the Contest?

By participating, you agree to be bound by these Guidelines and Rules and the decisions of Supercell. You may not enter the Contest with multiple identities. Any portion of the Contest may be canceled, suspended, and/or modified, fully or partially, if Supercell sees that any circumstances beyond its control hinders the proper functioning of the Contest.

The Supercell can disqualify anyone if they discover that the individual is trying to manipulate the entry process or the Contest's operation, breaking these Guidelines and Rules, behaving in a disruptive manner, or trying to disrupt the fair operation of the Contest, or if they are bothering, abusing, threatening, or harassing others.

Any attempt to deliberately damage or undermine the legitimate operation of the Contest may be in violation of criminal and civil laws and will result in disqualification from participation in the Contest. Should such an attempt be made, Supercell reserves the right to seek remedies and damages to the fullest extent of the law.

## **How Are Possible Disputes Resolved?**

Disputes regarding these Official Rules and/or this Contest will be governed by the laws of Finland. Decisions of Supercell are binding and final. No claimant in any dispute involving

Supercell shall be entitled to claim or obtain indirect, punitive, incidental or consequential damages.

Each winner agrees to release, discharge, indemnify and hold harmless Supercell and each of its respective officers, directors, employees, representatives, and agents from and against any claims and costs resulting, directly or indirectly, participation in any Contest-related activity or participation in this Contest.

In the event Supercell is prevented from continuing with the Contest by any event beyond its control, including, but not limited to, any fire, power failure, labor dispute, war, civil dispute, or government action (including any new law or regulation) or inaction then Supercell shall have the right to modify, suspend, or terminate the Contest. If any part of these Guidelines and Rules is found to be invalid or unenforceable, it shall not affect the validity or enforceability of any other provision. If a rule is considered invalid or unenforceable, these Guidelines and Rules shall otherwise remain in effect. Supercell's failure to enforce a particular term shall not constitute a waiver of that term.
